- ➤ Mr. Brandon announced that a Stetson University student named Chris Rentz is starting a Disaster Response group at Stetson. The Red Cross, through Francine Martin, is helping him with this project.
- ➤ Mr. Brandon next asked each member for an up-date on the activities of their organizations.
  - Yolanda Buckles, speaking for Jim Judge, Director of Volusia County Emergency Management:
    - They are monitoring the Tropics.
    - Testing is continuing at the Fairgrounds in DeLand Thursday Tuesday from 8 AM to 4 PM. Testing is free, but people need a photo ID and to print a voucher.
  - Frank Bruno, Co-Chairman, thanked everyone for all of the activities and wonderful help during the tornado.
  - Jean Rademacher with the United Way:
    - They are still working in the DeLand area after the tornado. Everything is coming along well.

- Mrs. Martin, with the Red Cross, gave an up-date on the response to the tornado:
  - By the Thursday after Tuesday's tornado, the United Way, Red Cross,
     Emergency Management, and many faith-based organizations were on the ground helping.
  - The work was very organized with the United Way and the Red Cross at Lowe's taking names and information.
  - Volunteers were doing clean-up work on Saturday which is consistent with the policy that the Red Cross has for volunteers.
  - She has called many of the homeowners who were helped and they have all had wonderful things to say about the response.
- Charlie Howell with Career Source:
  - Most of their staff is continuing to work from home dealing with clients virtually.
  - Work done in the office is mainly the handling of unemployment claims.
- Clay Jackson with Volusia County Community Assistance Division:
  - They are currently still accepting rental and mortgage assistance applications.

  - Regarding the tornado, they only had one person referred to them for help.
- Kristie Gillis with the Department of Children and Families:
  - They are working remotely with families to get information from them as well as out to them on additional resources that they need.
- Taryn Korkus with the Florida Department of Health:
  - They still have the COVID hotline available for information as well as where they can get testing done.
  - Still doing testing at their sites in Orange City and Daytona Beach.
  - Still distributing masks through outreach organizations.
